TERMS & CONDITIONS – Muslim Burial Society (MBS)

1. The membership shall cover the named person only
2. Membership shall run each calendar year from the 1st July to 30th June each year.
3. Failure to pay renewal fee, membership may be void
4. Once paid for, any fees are strictly non-refundable
5. All members are required to pay their fees by bank transfer.
6. It is the duty of each member to pay their yearly renewal fee
7. Joining Admin Fee for new members is £50. Over 50 years of age additional fees will apply
8. Annual Fee is £40 for members aged 50 and under.
9. This is an Islamic funeral support service for Muslims. Any Muslim may become a member, regardless of their country or region
10. The Society will not accept applications from persons of age 56 & above.
11. The Society will not accept applications from those diagnosed with terminal illnesses (at the time of joining) of any age
12. All members are responsible for informing the Society regarding any change of address, nominee and/or next of kin details
13. On the death of a member, the Society shall pay a maximum of £2000 to the funeral director on receipt of a death certificate
14. In the event that the society's funds are running low. The Society has the right to request for more funds (as applicable) or reduce the payment.
15. The Society is entitled to amend/modify the terms & conditions at every annual meeting including review of registration fee/annual membership fee
16. This policy is not death insurance or life insurance. The Society is intended for the mutual benefit and support of all members (support amongst all members) for the betterment of community keeping in view the community needs.
